1 INTRODUCTION

- 1.1 The R100 Campaign is a campaign whereby GT247 Proprietary Limited trading as GT247.com (“**GT**” or “**we**” or “**us**”) will give a bonus of R100 (“**Bonus**”) to every new client who opens a live trading account (denominated in Rand) (“**ZAR Trading Account**”) with GT through the campaign landing page which can be found at <https://www.gt247.com/claim-your-free-r100-trading-money> (“**R100 Campaign**”).
- 1.2 The R100 Campaign is subject to the terms and conditions set out below and is subject to and must be read together with the GT Terms and Conditions.
- 1.3 **The clauses in these terms and conditions that require your careful consideration are in bold font. You acknowledge that you have read and appreciated the importance of the terms and clauses in bold font.**
- 1.4 **By opening a ZAR Trading Account with GT, you agree to be bound by these terms and conditions.**

2 HOW TO QUALIFY FOR THE R100 CAMPAIGN

- 2.1 In order to qualify to receive your Bonus in the R100 Campaign, you must:
 - 2.1.1 be a South African citizen or resident;
 - 2.1.2 not be an existing client of GT;
 - 2.1.3 open a ZAR Trading Account with GT through the campaign landing page which can be found at <https://www.gt247.com/claim-your-free-r100-trading-money>; and
 - 2.1.4 have your ZAR Trading Account approved for trading by GT in accordance with GT’s account opening policies and procedures that includes verification in terms of the Financial Intelligence Centre Act, 2001 (“**FICA**”). This means that your account must be FICA verified in order for you to qualify for the R100 Campaign.
- 2.2 Live trading accounts that have not been opened through registration via the campaign landing page which can be found <https://www.gt247.com/claim-your-free-r100-trading-money> will not qualify for the R100 Campaign.
- 2.3 The R100 Campaign is not available to foreign nationals, existing clients of GT (ie existing account holders) and demo account holders.
- 2.4 Duplicate accounts do not qualify for the R100 Campaign. A “duplicate account” for the purposes of these terms and conditions refers to an additional and/or new account(s) opened by an existing client of GT. GT may in its sole discretion determine whether an account is a duplicate account.
- 2.5 Subject to clause 2.1, on the successful FICA verification of your ZAR Trading Account (ie your account has been approved for trading), GT will deposit the Bonus, within 3 business days from the date of successful FICA verification, into your ZAR Trading Account with GT which you can use for trading in accordance with the GT Terms and Conditions.
- 2.6 The Bonus which GT deposits into your ZAR Trading Account as contemplated in clause 2.5 may not be withdrawn out of your ZAR Trading Account. However, you may withdraw any profits that you have made through trading with the Bonus. All withdrawals are subject to the GT Terms and Conditions.

3 CAMPAIGN PERIOD

- 3.1 The R100 Campaign will run from 1 November 2018 to 31 December 2019 (“**Campaign Period**”).

- 3.2 Notwithstanding clause 3.1, GT may reduce or extend the Campaign Period in its sole and absolute discretion. You will be notified of same in accordance with clause 5.3.

4 INACTIVE TRADING ACCOUNTS

- 4.1 If you do not use the Bonus deposited into your ZAR Trading Account within 1 calendar month from the date of deposit into your ZAR Trading Account (ie you have not made any trades), GT reserves the right to immediately reverse the Bonus payment which was made to you in terms of this R100 Campaign.

5 GENERAL

- 5.1 Unless specifically otherwise provided, any number of days prescribed shall be determined by excluding the first and including the last day or, where the last day falls on a day that is not a business day, the next succeeding business day.
- 5.2 Except to the extent that any provision of these terms and conditions expressly provides otherwise, if the only day or the last day for the exercise of any right, performance of any obligation or taking (or procuring the taking of) any action in terms of any provision of these terms and conditions falls on a day which is not a business day, such right shall be capable of being exercised, or such obligation performed or action taken on the immediately succeeding business day.
- 5.3 **We may, at any time and in our sole discretion, amend these terms and conditions. The amendment will be effected by publishing the new version of these terms and conditions on our website and will apply to the R100 Campaign on the date of publication on our website. You acknowledge that by continuing to participate in the R100 Campaign, you agree to be bound by any new version of these terms and conditions.**
- 5.4 **In no event will GT be liable for any tax consequences that may arise. You must obtain your own tax advice in this regard.**
- 5.5 **GT reserves the right to cancel the R100 Campaign at any time, or to replace it with another campaign, as the case may be, by publishing same on our website or on written notice to you.**
- 5.6 The Bonus deposited into your ZAR Trading Account contemplated in these terms and conditions is not transferable or withdrawable.
- 5.7 **GT shall not be liable for, and you hereby indemnify GT against, claims for any loss, expense or damage which you may suffer, howsoever such loss, expense or damage may arise or be suffered, in respect of your participation in the R100 Campaign, your receipt of the Bonus or your trading using the Bonus.**
- 5.8 The above indemnity will not extend to any loss, expense or damage which arises as a result of the misconduct or negligence of GT or any director, employee or officer of GT.
- 5.9 We make no representations or warranties about the R100 Campaign of any kind, express or implied, including any warranties as to fitness for a particular purpose.
- 5.10 GT is not responsible for inaccurate campaign supplied to you by any third party who is not a representative or authorised by GT and connected with this R100 Campaign.
- 5.11 You acknowledge and agree that the copyrights, trademarks, service marks and all other intellectual property or other rights to any information distributed to or received by you whether sent by us or on our
