#### **1 INTRODUCTION**

- 1.1 The R100 Campaign is a campaign whereby GT247 Proprietary Limited trading as GT247.com ("**GT**" or "**we**" or "**us**") will give a bonus of R100 or USD10 ("**Bonus**") to every new client who opens a live trading account with GT through the campaign landing page which can be found at <u>https://www.gt247.com/claim-your-free-r100-trading-money</u> ("**R100 Campaign**").
- 1.2 The R100 Campaign is subject to the terms and conditions set out below and is subject to and must be read together with the GT Terms and Conditions.
- 1.3 The clauses in these terms and conditions that require your careful consideration are in bold font. You acknowledge that you have read and appreciated the importance of the terms and clauses in bold font.
- 1.4 By opening a live trading account with GT, you agree to be bound by these terms and conditions.

#### 2 HOW TO QUALIFY FOR THE R100 CAMPAIGN

- 2.1 In order to qualify to receive your Bonus in the R100 Campaign, you must:
- 2.1.1 not be an existing client of GT; and
- 2.1.2 open a live trading account (denominated in either Rand or US Dollars) with GT through the campaign landing page which can be found at <u>https://www.gt247.com/claim-your-free-r100-trading-money</u>. If you open a Rand denominated trading account, you will receive R100. If you open USD denominated trading account, you will receive USD10.
- 2.2 For the purpose of these terms and conditions, the term "Bonus" refers to either the R100 deposit into your trading account or the USD10 deposit into your trading account depending on the denomination of the trading account which you open with GT.
- 2.3 Only live trading accounts that have been opened through registration via the campaign landing page which can be found <u>https://www.gt247.com/claim-your-free-r100-trading-money</u> and approved for trading by GT in accordance with GT's account opening policies and procedures that includes verification in terms of the Financial Intelligence Centre Act, 2001 ("**FICA**") will qualify for the R100 Campaign. This means that your account must be FICA verified in order for you to qualify for the R100 Campaign.
- 2.4 The R100 Campaign is not available to existing clients of GT (ie existing account holders) and it is not available to demo account holders.
- 2.5 Duplicate accounts do not qualify for the R100 Campaign. A "duplicate account" for the purposes of these terms and conditions refers to an additional and/or new account(s) opened by an existing client of GT. GT may in its sole discretion determine whether an account is a duplicate account.
- 2.6 On the successful FICA verification of your account (ie your account has been approved for trading), GT will deposit the Bonus, within 3 business days from the date of successful FICA verification, into your trading account with GT which you can use for trading in accordance with the GT Terms and Conditions.
- 2.7 The Bonus which GT deposits into your trading account as contemplated in clause 2.6 may not be withdrawn out of your trading account. However, you may withdraw any profits that you have made through trading with the Bonus. All withdrawals are subject to the GT Terms and Conditions.

#### **3 CAMPAIGN PERIOD**

3.1 The R100 Campaign will run from 1 November 2018 to 31 January 2019 ("Campaign Period").



3.2 Notwithstanding clause 3.1, GT may reduce or extend the Campaign Period in its sole and absolute discretion. You will be notified of same in accordance with clause 5.3.

## **4 INACTIVE TRADING ACCOUNTS**

4.1 If you do not use the Bonus deposited into your trading account within 1 calendar month from the date of deposit into your trading account (ie you have not made any trades), GT reserves the right to immediately reverse the Bonus payment which was made to you in terms of this R100 Campaign.

### **5 GENERAL**

- 5.1 Unless specifically otherwise provided, any number of days prescribed shall be determined by excluding the first and including the last day or, where the last day falls on a day that is not a business day, the next succeeding business day.
- 5.2 Except to the extent that any provision of these terms and conditions expressly provides otherwise, if the only day or the last day for the exercise of any right, performance of any obligation or taking (or procuring the taking of) any action in terms of any provision of these terms and conditions falls on a day which is not a business day, such right shall be capable of being exercised, or such obligation performed or action taken on the immediately succeeding business day.
- 5.3 We may, at any time and in our sole discretion, amend these terms and conditions. The amendment will be effected by publishing the new version of these terms and conditions on our website and will apply to the R100 Campaign on the date of publication on our website. You acknowledge that by continuing to participate in the R100 Campaign, you agree to be bound by any new version of these terms and conditions.
- 5.4 In no event will GT be liable for any tax consequences that may arise. You must obtain your own tax advice in this regard.
- 5.5 **GT reserves the right to cancel the R100 Campaign at any time, or to replace it with another campaign, as the case may be, by publishing same on our website or on written notice to you.**
- 5.6 The Bonus deposited into your trading account contemplated in these terms and conditions is not transferable.
- 5.7 GT shall not be liable for, and you hereby indemnify GT against, claims for any loss, expense or damage which you may suffer, howsoever such loss, expense or damage may arise or be suffered, in respect of your participation in the R100 Campaign, your receipt of the Bonus or your trading using the Bonus.
- 5.8 The above indemnity will not extend to any loss, expense or damage which arises as a result of the misconduct or negligence of GT or any director, employee or officer of GT.
